FAECF Conference - Incubating the Future

FAECF organized together with well-known universities and organisations a successful conference on 27 May 2011 in Athens. The future Building envelope 2011 and the importance of energy saving were in the focus of the program. The conference was an opportunity for enlightening information by the experts and creators of the era, who are serving with respect the bidirectional relationship between environment and man in the construction of bioclimatic buildings with an emphasis on the importance of the envelope and new technologies, the design and the materials which are integrated in the reduction of energy losses, with respect for the environment and the landscape.

Contact with DG Environment

The next meeting of EuroWindoor with Mr. Pavel Misiga, Head of unit Economic Recovery and Sustainable Production from DG Environment is scheduled for October 2011. It will offer an opportunity for discussing the latest developments on GPP, Eco design and Eco labelling.

Working Group on Energy Rating

The EU WINners project has been refused by EACI, the agency delegated by the European Commission to evaluate proposals under the IEE scheme (Intelligent Energy – Europe). Though a lot of efforts had been put in the documents, it could not convince the agency to accept the working group's approach.

Another meeting took place on March 2nd for a presentation and discussion on an Energy rating system for windows developed by the ift Rosenheim. It is based on a simple room and window model, simple climate data and rating for 1 cooling and 1 heating day. A discussion following the presentation revealed some issues to be



cleared, so that a revised version will be presented shortly. The discussion is still going on.

Contact with DG Enterprise

Mr. Vicente Leoz-Arguelles, Head of Unit Construction, joined the EuroWindoor board meeting on March 23rd in Brussels. He reported on the CPR, which is adopted after more than 2,5 years of discussion and will come into full force from July 1st, 2013.

This date allows all actors on the market enough time for preparation. Mr. Leoz hopes for a common understanding of the CPR. EuroWindoor offered its cooperation for the dissemination of information in the EU member states.

EuroWindoor conference at fensterbau/frontale 2012

As the board of EuroWindoor is convinced that the European window-, façade- and glazing industry has an important role to play on an European level, EuroWindoor is together with the fensterbau/frontale management planning a half day conference at the fair fensterbau/frontale in 2012.

The overall idea is to promote the activities of EuroWindoor and to send the clear signal that the EU commission should cooperate with EuroWindoor in order to shape the best conditions for one of the most important industries when it comes to energy savings in buildings.

Fensterbau/frontale fair 2012 is held at the Nuremberg fairground from March 21st to March 24th, 2012. More detailed information about this important event will be published in the next newsletter.



FEMIB Study Tour 2011 to Switzerland

The next study tour of FEMIB goes to Switzerland. Starting on August 31st in Zürich, participants will visit local companies of the fenestration industry.
